You are requested to submit sealed quotation in duplicate for Hiring of payloader with 03(three) operator for 33 days in Turamdih (Mill) as per Blank Price Format (Annexure – PF).

Scope of work

Payloader shall be available throughout the day. The payloader will be used for pushing of ore in stock pile, lime stone, pyrosite and removal of lime and other rejects. However, the loader may also be used for any other type of work anywhere inside(or)outside the turamdih unit/area, depending upon the requirement and as instructed by the engineer-in-charge.

Commencement of work:

The work shall commence within 10days of placement of work order. Contractor will report to the Engineer Incharge, UCIL immediately on receipt of work order for further instructions for carrying out the job. A letter duly signed under contractor's official seal as a token of acceptance of all terms & conditions of work order must reach in the office within two days of receipt of the order. Contractor shall submit work commencement letter in duplicate (in prescribed format) to the Engineer In-charge -UCIL within two days of start of work at site as statutory requirement for onward transmission to the competent authority, Govt. of India, Ministry of Labour, Jharkhand. The work order no. & date as well as name of work must be quoted in all correspondences.

Period of Completion:

33 (Thirty three) days from date of commencement of the work (including Sundays).

Payment:

1 (one) R.A. bill and Final bill shall be paid.

Working period & Responsibility:

The payloader along with operator shall be available on all the working days(including Sunday & holidays) in Turamdih mill.

Payment:

A fixed hire charge for full day will be paid for keeping the pay loader along with operator in the plant. Apart from this, diesel @10.00lt/hour of run will be issued FREE depending on actual running hours. Payment will be made on monthly basis.

Insurance:

You have to arrange Insurance (ESI) coverage for manpower engaged for the work.

Award of contract:

The Contract shall be awarded on L1 basis.

Penalty:

- a. In case of unavailability of pay loader either because of breakdown of pay loader or unavailability of operator or any other case for more than 8 hrs. in a day but less than 12 hrs. 50% of the daily hire charges shall be deducted as penalty.
- b. In case of unavailability of pay loader for more than 12 hrs. in a day but less than 24 hrs. 100% of the daily hire charges shall be deducted as penalty.
- c. In case of unavailability of pay loader for more than one day and not supplying substitute pay loader, then actual hire charges of substitute pay loader by the corporation shall be charged as penalty or 1.5 times of daily awarded hiring charges will be deducted as penalty if the job is managed departmentally.
- d. In case of unavailability of pay loader for more than 8 hrs. a day for more than 4 occasion in a month, additional of 2 days hiring charges will be deducted from monthly bill.

In case of higher unavailability than above the Corporation reserves the right to cancel the contract. If the Company considers that the performance of the Contractor is unsatisfactory, or not upto the expected standard, the Company shall notify the Contractor in writing and specify in details the cause of the dissatisfaction. The Company shall have the option to terminate the Contract by giving one (1) month notice in writing to the Contractor, if Contractor fails to comply with the requisitions contained in the said written notice issued by the Company.

Rejection of Contract:

If concerned Engineer-in-Charge finds that jobs are not being done properly and there are slackness



in work or progress is not satisfactory, then reminder shall be issued to the party for the improvement and even then if not improved then contract shall be cancelled.

Safety:

You have to arrange all tools & tackles at your own cost like Gumboot, Gloves, Helmets, Goggles, Respirator etc. to all the persons engaged daily.

Medical

Medical fitness certificate for all employed persons from recognized doctor must be submitted to safety officer of UCIL before start and completion of the work.

Firm Price:

Price quoted shall remain firm till the completion of the work.

Rules and Regulations:

You have to follow all security, safety and labour rules of the Corporation.

Discrepancies and Adjustment of Errors:

- a. If there are varying or conflicting provisions made in any one document forming a part of the Contract, the accepting authority shall be the deciding authority with regard to the intention of the document.
- b. If on check there are found to be difference between the rates given by the Contractor in words and figures or in the amount worked out by him in the schedule of quantities and general summary the same shall be adjusted in accordance with the following rules:
 - 1. In the event of discrepancies between description in words and figures quoted by a Tenderer, the description in words shall prevail.
 - In the event of error occurring in the amount column of schedule of quantities as a result of wrong
 extension of the Unit rate and quantity, the Unit rate shall be regarded as firm & extension shall be
 amended on the basis of the rate.
 - 3. All errors in totaling in the amount column and carrying forwarded totals shall be corrected.

Rejection of Contract:

If concerned Engineer-in-Charge finds that jobs are not being done properly and there are slackness in work or progress is not satisfactory, then reminder shall be issued to the party for the improvement and even then if not improved then contract shall be cancelled.

Failure to pay minimum wages:

Contractors have to pay minimum wages and provident fund to their engaged worker within the schedule date as per the guideline of UCIL.If contractor fails of making payment to their worker within the schedule date in 2nd instance then the contract maybe short closed and penal action against the contractor for black listing procedure shall be initiated as per PWCP-2017.



Security Deposit:

Total amount of Security deposit shall be 10% of the awarded value of work.

Special terms and condition

- 1. The offered pay loader shall be registered as a commercial vehicle and shall have bucket capacity above 1.7 m³.
- 2. The pay loader shall be supplied along with competent operator with necessary valid license, permits for the contract period.
- The pay loader shall be in good working condition with good seat, tyres, bucket etc. The supplied new pay loader shall be in the name of tenderer.
- The bidder shall be the owner of the offered pay loader. Leased or hired pay loader is not acceptable against the enquiry.
- 5. All the documents connected with the pay loader, driver's license, and road permit etc. shall always be available in the vehicle.
- The offer must contain the valid recent address and contact telephone numbers of the owner in which be can be contracted 24 hours.
- 7. All the maintenance and related expenses will be borne by the bidder only
- 8. The cost of engine oil, lubricant, air & lube filter and any other consumable except diesel only will have to be borne by bidder.
- 9. Diesel at a rate of 10 liters (Ten)/hour of run will be provided free of cost by the Corporation from the Turamdih stores, based on the hour meter.
- 10. The operator will have to regularly get the logbook containing the details of running hours countersigned by the Engineer-in-Charge.
- 11. UCIL reserves the right to inspect the pay loader in detail and if the condition of the pay loader is not found satisfactory, then the Corporation reserves the right to reject the pay loader without assigning any reason.
- 12. In case of unavailability of the pay loader for more than 24 hours for any reason UCIL reserves the right to engage pay loader from any other source at risk & cost of the contractor.

Terms and Conditions:

1. Basis of Evaluation

Offer submitted by the bidder shall be in single part. Evaluation of L1 (Lowest) bidder shall be done based on their lowest quoted rate in totality. Bidder should quote their rate both in figures as well as in words. In case of any discrepancy in figure and words, rate written in words will be considered as final.

2. Rate

Bidders shall quote rates(s) / price(s) as per price format, Annexure - PF enclosed along with Enquiry. The quoted price shall be firm for this job.

3. Validity

The offer shall be valid for 120 days from the date of submission of offer.

4. Payment

Within 28(thirty) days after submission of your clear bill in 4 (four) copies on completion of the work to the satisfaction of our Engineer in charge. Against this work order, payment may be allowed through maximum one R.A. Bill and one Final Bill.

5. Agreed Liquidated Damage

If successful bidder fails to execute the order within the agreed completion period, they shall be liable to pay as agreed liquidated damages a sum @1/2% of the order value per week or part thereof of delay subject to a maximum of 5%.

6. Cancellation of Order

It will be your endeavour to execute the work order to our satisfaction. In case of your failure to do so, the order is liable to be cancelled.

7. Force Majeure

In the event of strike / lockouts, closure of work (whole or partial) breakdown of machinery, act of god or any other cause beyond our control, preventing or hindering the normal operation, we shall be at liberty to cancel this order at any time before completion of work without being liable to the bidder or other claims.

8. Disputes

Both parties agree in, disputes arising out of this order may be settled by arbitration, in accordance with the Indian Arbitration Act, 1940 & its subsequent amendment, by a sole arbitrator who shall be appointed by the Chairman & Managing Director of this organization (UCIL).

9. Jurisdiction

Any action / dispute arisen out of or from this work order shall be subject to the jurisdiction of court of law at Jamshedpur only, irrespective of anything to the contrary mentioned in the tender / quotation. Any statutory obligation has to be made by the contractor. Tenderer will extend all help.
