- a) Average Annual financial turnover during last three years ending 31st March of the Previous financial year, should be at least Rs. 39,719 /-
- b) Experience of having successfully completed similar works during last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following:
 - i. Three Similar completed works costing not less than an amount equal to Rs. 52,958 /-
or
 - ii. Two similar completed works costing not less than an amount equal to Rs. 66,198 /-
or
 - iii. One similar completed work costing not less than an amount equal to Rs. 1,05,917 /-.
- c) Bidder shall furnish PAN and GST Registration Number, IT Returns, Balance sheet and Profit and Loss statement of the last three financial years.
- d) The bidder should be OEM i.e. Accord Communications Ltd. or their authorised franchisees or channel partners or having experience of doing AMC of Accord Communications Ltd. Similar Digital EPABX systems of ADX - 600 or above versions with any reputed PSU's or Organizations.
In case of authorised franchisees and channel partner the bidders should submit a valid authorization certificate from the OEM and a certificate from the manufacturer indicating their technical competency (training / orientation programme certificate) of their personal in caring out the AMC activities of ADX-600 model Digital EPABX System failing which their offer will be rejected.
- e) The bidders should submit all relevant documents pertaining to their work experience such as copies of work orders, completion certificates failing which their offer will be rejected.

In case of registered units with MSME / NSIC / Director of Industries of State, Cotton Industries approved by the State Authority or any other entity as may be specified by Govt. guidelines, from time to time proper and valid certificate as documentary evidence shall be uploaded at UCIL e-proc site <http://www.etenders.gov.in> for exemption from submitting Cost of tender fees and/or EMD. Subsequently, the hard copy of this valid exemption certificate shall be submitted at the office of the Addl. Manager (Pers.), Narwapahar on or before 22.01.2025 at 03:00 PM in a properly sealed condition in separate envelope super scribing the Tender No. NWP / 977 Tender Closing date, Name of the Work & Name & Address of the Bidder.

The eligibility is to be decided strictly based on documents submitted at the time of receipt of tenders. No additional documents are to be allowed to be submitted after receipt of tenders but there is no bar to seek clarification or authentication of submitted documents. However in case of poor response, with a view to increase the competition, admission of additional documents to meet the Pre-Qualification Criteria may be allowed subject to the condition that

- 'Poor Response' implies when less than three bids are found suitable on the basis of submitted eligible documents as per NIT.
- The additional document should not be issued subsequent to last date of receipt of tender as mentioned in the NIT.
- The bidder submitting additional documents has submitted EMD and tender cost as prescribed in NIT.
- The opportunity of submission of additional documents will be given to all the bidders.

The Corporation reserves the right to accept or reject any or all tenders either in full or part thereof or to split up the work if necessary without arranging any reasons whatsoever.
