- 2. <u>Completion Time:</u>
  30 (Thirty) days (including Sunday & holiday) from the date of issue of work order/ commencement of work at site.
- 3. Payment Terms:
  One (1) R.A and One (1) Final Bill will be paid against this work after submission of quadruplicate bill. Final bill should be submitted within 30 (Thirty) days from the date of completion.
- 4. Working period:
  General Shift (excluding Sunday & holiday) as per direction of Engineer –in-charge. 07:00 AM to 12:00 Noon and 02:00 to 05:00 PM.
- 5. Rate:
  The rate shall be quoted by the contractor must include all taxes (GST) & Duties, PF, PPE, Insurance, etc. No extra payment will be entertained after rate quoted by the contractor.
- 6. Minimum wages, EPF, Bonus, Insurance, Safety appliances and tools & tackles, contractor's profit should be included in quoted rate. No extra payment will be made thereafter.
