You are invited to offer sealed quotation for the subject work schedule of quantity in duplicate) in the enclosed schedule of quantity based on the terms and conditions given below: -

1. TAXES: The quoted rates should be inclusive of all taxes & duties.
2. Completion time of work: Total work should be completed within **35 days (Excluding paid holidays if any in between the period)**, from the date of commencement of work, which shall be within 07 day from the date of issue of LOI/work order.
3. The offer must be valid for six months from the date of tender opening, and no contractor shall be allowed to withdraw his/their offer within this period
4. There will be no defect liability period for this work.
5. Material, LPG and Fuel has to be arranged by Contractor, the same will be reimbursed based on documentary evidence. (Fuel @ 10 kilometer per litre will be reimbursable).
6. The price quoted should be firm and no escalation on any account whatsoever will be entertained/paid by the Corporation.
7. Payment would be released by UCIL Turamdih/ Jaduguda.
8. Two RA Bills - One RA bill&one final bill will be paid for this work.
9. Necessary workmen insurance for 29 (Two) Nos. minimum shall be obtained by the contractor for the workmen engaged at site, at their own cost for the whole period of contract and shall be furnished to the corporation before commencement of the work without which contractor will not be allowed to start the work.
10. In case of stoppage of work by local people/Bandh or any other reasons no idle charge will be paid by the corporation towards Labour, Plant and machinery etc to the contractor against this work.

11. You shall have to provide the facilities under the provision of Contract Labour (Regulation & Abolition) Act, 1970 – Section – 16, 17, 18 and 19, Chapter-V – “Welfare and Health of Contract Labour.”
11. The contractor shall maintain safety precautions during the execution of work. Contractor at their own cost shall provide safety appliances to the workmen.
13. All the labour rules shall be followed strictly as per Contract Labour (Regulation & Abolition) Act, 1970. All registers, forms stipulated under minimum wages (Central rule) Act, 1950 should be maintained by the contractor and to be furnished to the Corporation before commencement of the work. In the event of the breach of aforesaid conditions, the contractor shall be open for action as deemed fit by the concerned labour authorities of the Central Government.
14. Contractor shall strictly abide by the security rules and regulations enforced by the owner time to time. The contractor shall provide proper identity cards, badges etc to his employees wherever directed by the Engineer.
15. Quotations must be submitted in the enclosed schedule of quantity (original and two copies in Xerox of the same) duly signed along with seal of the agency. Duly filled quotations shall be submitted in a sealed envelope and to be deposited in the office of Manager (Pers), Turamdih upto **19/ 11/ 2024 (12.00 Noon)** and will be opened on same day at **3.30 P.M** at Turamdih.
16. **All other terms and conditions shall be applicable as per General conditions of UCIL’s tender norms.**
