- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 9. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

10. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

11. Inspection

Nominated Inspection Agency: On behalf of the Buyer organization, any one of the following Inspection Agency would be conducting inspection of stores before acceptance: Pre-dispatch Inspection at Seller Premises (applicable only if pre-dispatch inspection clause has been selected in ATC):

1) Dispute resolution Mechanism and Jurisdiction:

- a) **Conciliation**: Notwithstanding anything contained in this contract, any disputes or differen ces whatsoever, which are to be settled amicably between the parties with their authorized re presentative, shall be resolved through conciliation.
- b) **Mediation**: Any disputes or differences, which are not settled amicably through conciliation , then either of the parties, may approach for mediation to settle under mediation Act, 2023. T he procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c) **AMRCD**: Any disputes or differences between the parties are not settled amicably with con ciliation and/or Mediation, then such disputes or differences shall be resolved through Adminis trative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d) **ARBITRATION**: Any disputes or differences where clause no. (c) is not applicable, the parti es may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all ot her cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e) **Jurisdiction**: If the matter is not resolved through above means, the dispute shall be resolv ed in civil court of law at Jharkhand only.

2) PRE-QUALIFICATION CRITERIA:

a) The bidder should be OEM or their authorized dealer of specific make/brand mentione

d in the tender.

- b) In case of authorized dealer, a copy of valid authorization certificate from the principa I must be submitted.
- c) The bidders average annual turnover during last 03 financial year i.e 2020-2021, 2021 -2022 and 2022-2023 ending 31st march should be at least Rs. 12.82 lakhs. Audited bal ance sheet and profit and loss account must be submitted by the bidder in support of a bove.
- **3)** Guarantee/Warranty: Guarantee/ warranty shall be as 12 months from the date of receipt and acceptance of material at our store.
- Related party clause: Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. - 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
