The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 4. Generic

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

10. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

11. Inspection

- d) **ARBITRATION**: Any disputes or differences where clause no. (c) is not applicable, the parties m ay go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the di sputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the val ue of the dispute and not the value of the contract which may be much higher. In all other case s, arbitration shall not be a method of dispute resolution arising out of this contract.
- e) **Jurisdiction**: If the matter is not resolved through above means, the dispute shall be resolved i n civil court of law at Jharkhand only.
- 2) GURANTEE/WARANTEE: Material should be Guaranteed/Warranted for t he period of 12 months from the date of receipt and acceptance of materi al at our store or 1000 Percussion hour within 12 months from the date of receipt & acceptance of material whichever is earlier.
