1. Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION:** Any disputes or differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e. **Jurisdiction:** If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jharkhand only.

3. **Guarantee/warranty:** Material should be Guaranteed/Warranted for the period of 18 months from the date of receipt and acceptance of material at our store or 500 operational running hour within 18 months from the date of receipt and acceptance whichever is earlier against manufacturing defects excluding abnormal failures such as operation/ maintenance faults / conditions such as presence of water, side cuts piercing by material other than the mine ore/waste.

4. **PRO RATA PENALTY:** In case the life obtained of the tyres is lower than the Guaranteed life as claimed in guarantee/warranty, a penalty amount will be deducted on pro-rata basis. Pro-rata Penalty amount will be calculated on proportionate basis.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
