

**Status of compliance of environmental condition of uranium recovery plant from copper tailing at Mosabani for the capacity of 0.9 MTPA located at Mosabani, East Singhbhum District, Jharkhand as on March 2026**

After several meetings with the forest department, revised report with revised fund has been prepared and has been submitted for its approval to forest department vide our letter no UCIL/Env/Forest/WL/04/2022 dated 16.09.2022. Meeting was again conducted by DFO, Jamshedpur on dated 09.05.2023 to discuss the above proposal. Further DFO, Jamshedpur has asked for certain documents vide its letter no. 2396 dated 16.10.2023. Requisite documents are under preparation. The proposal is on hold due to uncertainty of the project commissioning.
