Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

1. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration
2. Bidders can also submit the EMD with Account Payee Demand Draft in favour of URANIUM CORPORATION OF INDIA LIMITED payable at SBI, JADUGUDA
Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.
3. Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of URANIUM CORPORATION OF INDIA LIMITED payable at SBI, JADUGUDA
. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.
4. Buyer Added text based ATC clauses

Name of Work: "Deployment of Manpower for Underground Civil work at UCIL Jaduguda Mine for 01 Year"

Total Estimated Cost Rs. 61,37,329.00 including GST

Duration of tender = 01 (One) Year

Earnest Money Deposit (EMD) (D.D./Banker's cheque/ BG only in favour of Uranium Corporation of India Limited Only) : Rs. 61,373.00

The eligible criteria to qualify in Techno commercial Part are as below:-

1. Average Annual financial turnover during the last 3(Three) consecutive financial years, ending 31/03/2024 shall be at least 30% (18.41 Lakhs) of the estimated cost supported by the audited annual accounts of each year.
2. Bidder shall have successfully completed similar works during last 7 (Seven) years ending on 30.09.2024 as per any one of following:
 - a) Three(3) similar completed works each costing not less than the amount equal to 40% (24.55 lakhs) of the estimated cost
or
 - b) Two (2) similar completed works each costing not less than the amount equal to 50% (30.69 lakhs) of the estimated cost
or

- c) One (1) similar completed works costing not less than the amount equal to 80% (49.10 lacs) of the estimated cost.

3. Bidders must attach Work Order and work done certificate mentioned executed amount and date of completion.
4. Similar works means “Experience in execution of work with any Central /State Govt. Organization /PSU for **Any Manpower Deployment work**”.
5. **GEOGRAPHIC PRESENCE:** Office registration certificate: Registered office or at least one of the registered branch office of the bidder shall be located and registered within the geographical limits of **Jharkhand state**. Documentary evidence must be provided in the form of Municipality trade licence or other such documents as per the following which satisfies as a proof of having the office establishment.

A) Trade licence issue by the local authority in the name of the Firm or

B) Landline phone number in the name of the Firm or

C) Electricity bill for last one year in the name of the Firm or

D) GSTIN registration or

E) Udyam /MSME /Udyog Aadhaar certificate.

F) Office rent agreement is not acceptable/ not valid.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
