This Bid provides for Trade Receivables Discounting System (TReDS) as Preferred mode of payment. 1. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference/price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which will be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bid. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 perc at the time of issue of the contract. However, once the contract is issued, contract quantity or contract durati can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

PRE-QUALIFICATION CRITERIA (PQC)/ ELIGIBILITY CRITERIA

1. **FINANCIAL STANDING:**

Minimum Average Annual financial turnover during the last 3 (Three) consecutive financial years, endi 1/03/2025 shall be at least 30% i.e. Rs. 113.85 Lakh of the estimated value as per actual profit and lo atement and Balance sheet for the last three financial years.

2. **PAST PERFORMANCE AND PAST EXPERIENCE etc. CRITERIA:**

The bidder shall have to produce documentary evidence to prove their job experience in si r works during last 7(seven) years ending on last day of month previous to the one in which applicatio re invited. Documentary evidence in the form of **work order and completion Certificate copies** sp ying the work and amount of contract should be uploaded:

- a) One (1) similar completed works costing not less than the amount equal to 80% i.e. Rs. 303.62 Lakh of th timated cost.

- b) Two (2) similar completed works costing not less than the amount equal to 50% i.e. Rs. 189.76 Lakh o estimated cost

3. The Bidder shall furnish a copy of MII, GST, MSME/NSIC, PF and ESIC Registration.

Note: 1. similar works means “Experience in execution of “Transportation work of Minerals Tailings/ Sand/ Aggregates/ Fly Ash/ Other Minerals in any Govt./PSU/Public Ltd. Organization/Private Limited Organizations””

2. Offers of the tenderer will be rejected if they fail to fulfill the above criteria.

4. **RELAXATION OF CONDITIONS OF PRIOR TURNOVER AND PRIOR EXPERIENCE:**

- i. EMD exemption only to relevant MSME/MSE.
- ii. Turnover exemption only for relevant Startups as per government guidelines.

5. **GEOGRAPHIC PRESENCE:**

The bidder participating in the bid must have the Head Office or a Branch Office in the East Singhbhum district of Jharkhand. Any document issued by Govt. of India or Govt. Authority of Jharkhand shall be considered for address proof like UDYAM, GSTIN, Trade License issued by Govt. Authority of Jharkhand etc.

Note: - 1. Mere submission of Rent Agreement shall not be considered for Office Address proof.

2. without submission of relevant documents regarding existing of Bidder in East Singhbhum district, tender will be disqualified in Techno-Commercial Bid without any prejudice.

DETAILED SCOPE OF WORK

The scope of this tender will be generally as per specification schedule of quantities and general / special conditions of contract and as directed by Engineer in charge, on behalf of Corporation. However, the scope of work covered complete in all respects under this contract are as follows:

1. Loading of Uranium ore by mechanical means like wheel Loader from UCIL, Bagjata Mines and transportation of the same up to Mill of UCIL, Jaduguda in covered and well maintained Tippers/Dumper and dumping the same at ground hopper of UCIL Mill, Jaduguda including weighment at Jaduguda weigh bridge as per directions of Engineer-in-charge.

2. Loading of Mill Tailing by mechanical means such as wheel loader/JCB Loader from UCIL Jaduguda tailing paddock, weighment of tailings to be done at Jaduguda weigh bridge and transportation of the same up to UCIL, Bagjata Stowing yard in covered and well maintained Tippers/Dumpers, inclusive of all handling, tools etc. complete, as per directions of Engineer-in-charge.

3. Bagjata Mines is located 32 km East of Jaduguda Mines and 11 km East of Mosak

Mines in the Singhbhum East district of Jharkhand State.

4. For quality check of ROM, all Tippers carrying ore have to pass through the BOA (Bulk Ore Analyzer)/ARCH Room before it is being dispatched to Jaduguda.

5. Schedule of work mentioned in BOQ to be carried out as per direction of Engineer in-charge.

6. The heavy vehicles required for the work on hire basis should not be manufactured earlier than the year 2019.

7. Spillage etc during transportation of ore and tailing

While transporting, all loaded dumpers/Hyva etc must be covered with Tarpaulin as per following specification.

(a) Tarpaulin made of canvas/high-density polyethylene cloth stitched and having nets fitted on all borders. The size of the tarpaulin shall be larger than the dump box as to cover the top of the dump box completely.

(b) The tarpaulin is to be fixed on all side hooks of the dumper in such a way that a gap of at least 200mm will be below from the rim of the dump box.

(c) Tarpaulin must be changed as and when insisted by the Engineer in charge, to avoid the dust and spillage in the public surrounding area/villages/on road.

8. Dumping of ore and tailing outside company area

If dumping of ore or tailing becomes unavoidable due to repair and maintenance or any other reasons like overturning or any other accidental causes the Tenderer shall clear the dumped ore or tailing within 48 hours of such incident and failing to do so the UCIL shall take steps to clear the ore or tailing and the cost incurred shall be deducted from the running bill of the Tenderer. The cost involved to clear the ore or tailing shall be intimated to the Tenderer within 48 hours before carrying out the work and if the Tenderer does not reply immediately after getting the intimation it will be deemed that the Tenderer has no objection to the estimated cost.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकार पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restr on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
