Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

# Pre Qualification Criteria

1) Bidder shall be **manufacturer of Mechanical seals or their authorized dealer**. Authorized dealer shall submit valid tender specific authorization certificate from the manufacturer, along with part-1 of their offer, failing which their offer shall be rejected.

2) If both manufacturer and its authorized dealer participate in the tender, only manufacturer offer shall be considered.

3) The bidder should submit previous Purchase Order copy along with its Invoice for supply of mechanical seals to any company during the last 3 years ending with last date of previous month on which date tender is floated, along with part-1 of their offer, failing which their offer shall be rejected.

4) The average annual financial turnover of the Bidder shall be **Rs.3,45,150/-** for last 3 financial years (2022-2023, 2023-2024 & 2024-2025). In support to same bidder shall submit audited report / profit and loss statements where in Auditors UDIN number shall clearly mention as a proof along with part-1 of their offer, failing which their offer shall be rejected. As per ICAI notification all the certificates and audit reports should consist of UDIN generated by the CA.

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regard. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
