6. Rejected goods will be lying at the UCIL's store at the supplier's risk and shall be removed by the supplier at his own cost immediately on receipt of rejected advice. The Corporation will not be responsible for any loss on account of deterioration etc. of the rejection goods. If rejected goods are not removed by the supplier, UCIL may charge penal rent and dispose of the goods as deemed.

- 10) **LIQUIDATED DAMAGE (LD):** As per GeM GTC.

For the portion of delay which is attributable to UCIL / force majeure or to the supplier / contractor, the case shall be dealt with as follows :

A. Delay attributable to UCIL / Force majeure

LD	Not Applicable
Taxes & Duties	Any increase in taxes and duties on account of statutory increase, fresh imposition of any duty or taxes which take place during such extended period shall be admissible.

Taxes & Duties	Increase / fresh imposition of taxes and duties during the extended period will be to the account of the supplier/contractor. Any decrease in taxes and duties during the extended period will be availed by UCIL
Price Variation	Price variation, if indicated in the contract will be applicable for the work performed within the scheduled period of contract. For work executed during the extended delivery period, the rates as prevailing on the last day of the scheduled contract period only may be paid. De-escalation / reduction, if any, which takes place, shall have to be passed on to UCIL

- 11) **PRO-RATA PENALTY :**

Ø For NaCl Content (on dry basis) :-

- i) If NaCl content is below 98% but upto 88% penalty shall be as follows:-
- a) Below 98% but upto 95%-pro-rata amount on the basis of landed value shall be deducted.
 - b) Below 95% but upto 93% double the pro-rata amount on the basis of landed value shall be deducted
 - c) Below 93% but upto 90% triple the pro-rata amount on the basis of landed value shall be deducted

- d) Below 90% but upto 88% four times the pro-rata amount on the basis of landed value shall be deducted

Ø **For Insoluble content (on dry basis):-**

- a) 0.2-<0.5% : No deduction
b) ≥ 0.5 -<1.0% : Fifty rupees per MT of salt supplied during that week.
c) ≥ 1.0 -2.0% : Hundred rupees per MT of salt supplied during that week.
d) ≥ 2.0 -3.0% : Two hundred rupees per MT of salt supplied during that week.

Ø **For Moisture content:-**

- a) Less than 5.0% : No deduction
b) More than 5.0% : Weight of additional moisture above 5.0% will be deducted from the received material to arrive at the weight of material for payment purpose.

Pro-rata deduction will be made on the total quantity of the material received within a week based on the analysis of the composite sample of that week.

e) **Sampling Schedule :-**

- Composite samples will be made from all the individual consignments on bi-weekly basis for analysis.
- Payment will be made for material received on bi-weekly quantity, based on the analysis of composite samples, after deduction as mentioned above.
- Week will be bifurcated from Monday to Wednesday and Thursday to Saturday for bi-weekly sampling.
- Pro-rata deduction will be made based on analysis of bi-weekly composite samples.
- Analysis results of UCIL's laboratory shall be treated as final and binding.

f) **Material Chemical analysis:**

Sample will be drawn from each consignment at the time of unloading at site. Biweekly composite samples will be analyzed in UCIL laboratory, which will be final and binding. **The party can depute his representative at the time of unloading and sampling or else sampling done by UCIL at the time of unloading shall be treated as final and binding for both the parties.**

- g) Re-Sampling of material will not be allowed in any case.
h) There is no Re-analysis of material allowed in any case.

12) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**

- a. **CONCILIATION:** Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.
- b. **MEDIATION:** Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c. **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between C

PSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.

- d. **ARBITRATION:** Any disputes or differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e. **JURISDICTION:** If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jharkhand only.

Note:

- 1) Material is required to be supplied on FOR-destination basis duly unloaded & insured basis.
- 2) As staggered delivery schedule and Pro-rate deduction clause given in the bid document, hence offline calculation of LD and pro-rata penalty will be done by Paying authority during the time of making payment to the supplier.
- 3) PUC certificate of Pollution Control, if applicable should be submitted along with the supply of materials.
