However apart from this if any inconclusive situation arises in future regarding PVC, same may be settled down on mutual agreed terms and conditions.

Average quarterly WPI index for Steel drums and barrels for this bid on the date of bid publication shall be considered as :-

Average WPI index of Steel drums and barrels =

$$\frac{\text{Oct'25} + \text{Nov'25} + \text{Dec''25}}{3} = \frac{148.3 + 147.8 + 148.1}{3} = 148.06 \text{ (Fixed for this bid)}$$

Remarks: Any change in WPI of any month at a later stage which was published on the website of office of Economic Advisor if found, the same will be applicable for consideration of PVC calculation wherever applicable.

- b) Bidder shall submit average quarterly price index of Steel drums and barrels at the time of offer. Copy of whole sale index price from economical advisor, Govt. of India will be submitted along with offer as a proof.

c) Average WPI consideration of supply month shall be calculated as below:

If the material supplied in Aug'26, then considerable average quarterly WPI for the supply month will be:-
