- 9) **SAMPLING:** Sampling of individual consignment will be done by grab sampling method, in the presence of party or his representative or in absentia at the time of unloading material at our site.
- 10) **ANALYSIS REPORT:** Analysis report of UCIL will be final and binding to the party. The analysis v

value will be rounded off to the nearest integer. Decimal fraction above or equal to 0.5 shall be rounded off to next integer whereas below 0.5 shall be rounded off to previous integer.

**For Example: If analysis value comes 74.49%, it will be rounded off as 74% & if it comes 74.50% then it will be rounded off 75%.**

However, if party desires a re-analysis of material below 75% Ca(OH)<sub>2</sub>, it can be carried out in our laboratory upon written request, in presence of party's representative and shall be within 15 days of reporting of the analysis. In the event of non-receipt of request for re-analysis, UCIL'S earlier report will be treated as final. Re-sampling will not be done under any circumstances; Party must contact the user department for analysis of the individual consignment within specified time.

- 11) **PRO-RATA PENALTY:** Hydrated Lime supplied should be having minimum 80% Ca(OH)<sub>2</sub>. For supply having less than 80% Ca(OH)<sub>2</sub> content, pro-rata deduction shall be effected on the basis of landed value as under :
- a) If the Ca(OH)<sub>2</sub> content is below 80% but up to 75%, Single pro-rata deduction will be effected on the basis of landed value of particular invoice.
  - b) If the Ca(OH)<sub>2</sub> content is below 75% & up to 65%, double pro-rata deduction on landed value of particular invoice will be applicable.
  - c) In case of above (a) & (b), you will not be allowed to take back the material for replacement.
  - d) If the Ca(OH)<sub>2</sub> content is below 65% Ca(OH)<sub>2</sub> may be accepted at the discretion of UCIL with triple pro-rata deduction of particular invoice. UCIL shall have the right to accept part quantity of a consignment having Ca(OH)<sub>2</sub> below 65%.
  - e) Payment with or without deduction will be made based on the analysis of individual truckload, rejected material, if any, shall be replaced within 15 days of information. Analysis report of material below 75% Ca(OH)<sub>2</sub>, will be intimated to your representative available at the site by hand or will be informed to you by e-mail within 10 working days of supply.

**For Example: If analysis value comes 79.49%, it will be rounded off as 79% & if it comes 79.50% then it will be rounded off 80%.**

- 12) **Deviation of Order Quantity:** Up to 10% variations in the execution of purchase order of the total order value for sanctioned order value is allowed without issue of amendment / revision in the purchase order.
- 13) **Removal of scrap/empty lime bags shall be under supplier's scope.**
- 14) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**
- a) **CONCILIATION:** Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.
  - b) **MEDIATION:** Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
  - c) **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government

t Department(s) / Organization(s) shall be taken by either party for its resolution through AMRC D.

- d) **ARBITRATION:** Any disputes or differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e) **JURISDICTION:** If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jharkhand only.

**Note:**

- 1) Material is required to be supplied on FOR-destination basis duly unloaded & insured basis.
- 2) As staggered delivery schedule and Pro-rata deduction clause given in the bid document, hence offline calculation of LD and pro-rata penalty will be done by Paying authority during the time of making payment to the supplier.
- 3) PUC certificate of Pollution Control, if applicable should be submitted along with the supply of materials.
