In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

7. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - 1) **SCOPE OF SUPPLY:** Supply of Stable Bleaching Powder at our Turamdih Mill Site, Unloading from truck and stacking at our stores /site stores /godown. Jaduguda Mill is 06 KM away from Tatanagar Railway station. In case of emergency, truck loaded consignment material shall be diverted to unload at Jaduguda Plant which is 06 KM from Tatanagar Railway Station without any financial implication. Such information of diversion shall be intimated to the party by HOD (Stores) in mail at least seven days before the diversion of the specific lot. No amendment will be given for such diversion
- 2) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will be liable to be rejected. Conditional offer will also be liable to be rejected.
- 3) **Delivery Schedule:** As mentioned in bid. However delivery quantity in each lot may vary by 10%.
- 4) Unloading of material at site is under the scope of the work of the supplier. The material should be delivered at WTP of Turamdih township through Central store of Turamdih Mines.
- 5) Material should be in 25 Kg of laminated HDPE bags having two inner liners and tied at the mouth.
- 6) Test certificate should be furnished along with each consignment. Sampling of each consignment shall be done at our end with grab sampling method and shall be analyzed in our lab. Our analysis shall be treated as final and binding to both.
- 7) The analysis value will be rounded off to the nearest integer. Decimal fraction above or equal to 0.5 shall be rounded off to next integer whereas below 0.5 shall be rounded to previous integer.
- 8) **Pro Rata Penalty:-** Bleaching Powder supplied should be having minimum 34% chlorine. For supply having less than 34 % chlorine content, Pro Rata deduction shall be effected on the basis of landed value of particular invoice as under:-
 - a) If the Chlorine content is below 34% but up to 30% Pro Rata deduction will be effected on the basis of landed value of particular invoice.
 - b) If the chlorine content below 30% material may be rejected.
 - c) In case of (a) you will not be allowed to take back of material for replacement.

For Example: If pro rata value comes 33.49%, it will be rounded off as 33% & if it comes 33.50% then it will be rounded off 34%.

- 12) **Earnest Money deposit.**: Bidders who are not exempted for EMD as per GEM exemption rule has to upload scanned copy of EMD document and hard copy of the same must be reach to UCIL Purchase dept within 05 days of bid end date in a sealed envelope super scribing GeM Bid no. and Bid End Date to the following address, **Failing which offer shall not be considered.**:

13) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**

- a) **CONCILIATION:** Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.
- b) **MEDIATION:** Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c) **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d) **ARBITRATION:** Any disputes or differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e) **JURISDICTION:** If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jharkhand only.

- 14) **Deviation of Order Quantity:** Up to 10% variations in the execution of purchase order of the total order value for sanctioned order value is allowed without issue of amendment / revision in the purchase order
